- The negligent omission, concealment, or falsification of requested academic, medical-psychological, personal, or social information shall entitle YAGO SCHOOL to **terminate the current academic enrolment or to decline the renewal of enrolment for the following school year**, without the parents/legal guardians of the student being entitled to a refund of any fees already paid.
- In exercising the right of admission, the renewal of enrolment for a new academic year is solely at the **discretion of YAGO SCHOOL**, provided there is a justified reason for doing so.
- If a student exhibits any learning difficulties, YAGO SCHOOL will inform the parents/legal guardians to arrange the necessary **internal or external support**. These specific supports will incur an additional cost for the families. A student with specific educational and/or social needs will only be admitted if the school can offer a programme that meets their individual needs.
- Students joining the school from PYP 5 (Year 3) onwards are required to take **mandatory Chinese reinforcement** classes, and reinforcement in English or Spanish as a foreign language will be obligatory from PYP 4 (Year 2) when recommended by the school.
- For students coming from a foreign educational system, enrolment will be based on their **date of birth**.
- The decision to allocate available places lies exclusively with the **Management Team**, based on their judgement, and no other party may influence their decision.
- Enrolment will not be renewed for students who have **caused disciplinary issues** during the academic year. This decision will be communicated by the Management to the parents/legal guardians at the end of the year.
- Enrolment will also not be renewed for students whose parents/legal guardians have **outstanding payments** owed to the school by the end of the academic year, regardless of the reason for the debt.
- The school reserves the right to **allocate the places** of students whose parents/legal guardians have not paid the reservation fee within the specified deadlines, with the Management Team deciding whether to fill these places.
- By formalising the enrolment, parents/legal guardians implicitly accept this regulation and any other school rules, as well as its ethos.
- The school may choose **not to renew a student's enrolment** if there is persistent, unjustified, or inappropriate non-compliance with the rules of conduct and the Internal Rules and Regulations by either the students or their parents/legal guardians.

- Parents/legal guardians of **Yago School Nursery** students who have not paid the full enrolment fee must do so by the end of January of the preceding academic year to secure their place in the Senior School.
- The contract between the school and the parents/legal guardians is for the **entire academic year**, regardless of the chosen payment instalments.
- **Enrolment and Reservation Fees are non-refundable** in the event of a cancellation of the place.
