## BOARDING HOME

<b>ENROLMENT FEE</b>	<b>1.660€</b>	One-off payment necessary to confirm the place. This fee is non-refundable.
<b>DEPOSIT</b>	<b>2.080€</b>	One-off payment that is refundable upon departure.
<b>ACTIVITY FUND</b>	<b>520€</b>	Per term.
<b>PLACE RESERVATION FEE</b>	<b>1.000€</b>	In <b>March</b> , parents of pupils already enrolled at Yago School pay the reservation fee for the following academic year. This amount will be deducted from the September invoice for the following academic year.

The amount of the place reservation and enrolment fees will not be refunded in the event of cancellation.

### PAYMENT DETAILS AND FURTHER INFORMATION

- The enrolment of your child is considered completed when:
  - The application has been received and reviewed by the Admissions Department.
  - The enrolment fee and deposit have been received by the school.
- Deposit:** Will be refundable on departure (This will show as credit to your account less any additional expenses incurred by the student or any possible damage).
- Payments must be made on a **termly or annual basis**, via direct bank transfer. For termly payments, they must be submitted 60 days before the beginning of each term (June 30th, October 31st and January 31st). Annual payment must be submitted 60 days before the beginning of the Academic Year (June 30th).
- The School is governed by internal **rules and regulations**, of which the parents declare they have been informed and are obliged to comply with.
- The Student's Parents / Legal Guardians are jointly and severally responsible for the payment of the Yago School Fees.
- Uniforms and books** must be purchased at the School shop.
- Parents are encouraged to speak to the Yago School Billing office to discuss any potential late payments and arrange for an adjusted payment plan. The student will not be allowed to attend school until the payment plan has been approved.
- Payment of fees:** Fees are due 60 days in advance and must be paid in full at the beginning of each term. Late payment of fees is not permitted. The school reserves the right to withdraw a place from a student whose fees are more than 20 days overdue. In the event of fees being more than 30 days overdue the student will not be allowed to come back to the boarding house until the matter is resolved.
- Notice of withdrawal:** Notice in writing, 60 days before the first day of term is required where it is intended that a student should leave at the beginning of that term. Otherwise, a term's fees in lieu of notice is chargeable. In the case of an annual payment, a whole term's fees will be held.
